2. The interested Auction-Purchase-Bidders may visit the premises of Ela, Old Goa - 403 402 (Goa) in order to inspect the items offered for Auction, on **“As is, Where is basis”** on any working day during 11.00 AM to 4.00 PM, before the Last Date of submission of sealed Auction-Bids.
3. The bidders enclose (along with their bids) the EMD/Bid Security of the requisite amount Rs. 10,000.00 in the form of D.D. only in favour of **ICAR Unit, CCARI, payable at Old Goa** (No quotation shall be considered without the EMD/Bid Security). The sealed bid must reach the Director, ICAR-Central Coastal Agricultural Research Institute, Ela, Old Goa - 403 402 on or before the last date and hour for submission of bids. Late Auction-Bids (i.e. Bids received after the last date and hour or receipt) shall not be considered.

The interested Auction-Purchase-Bidders should fill up the Auction-Purchase-Bid Forms in the prescribed format (uploaded on our website) and enclose the necessary EMD/Bid Security, along with a Self-Attested copy of identity-proof and a Self attested Passport Size Photograph, in a sealed envelope.
5. The Auction-Purchase-Bid of the highest acceptable responsive Bidder will be accepted, subject to such highest Bid Price being equal to or more than the Reserved price of the condemned store items.
6. The successful Auction-Purchase-Bidders must deposit full payment (i.e. residual amount after adjusting the EMD/Bid Security) within next two working days and must lift/take over the condemned store items four working days from the Bid-opening date, otherwise the EMD/Bid Security shall be forfeited.
