Duly completed application form should be submitted in the proforma appended, accompanied with a latest passport size photograph, attested copies of certificates for proof of age, educational qualifications, marksheets, degree certificate, experience, caste status (in case of SC/ST/OBC certificate issued by the Competent Authority in the prescribed form)
2. The prescribed qualifications are minimum. Where the number of applications received in response to advertisement is large, the Institute will restrict the number of candidates as per norms.
3. The Director, ICAR-CCARI, Goa reserves the right to shortlist the candidates for written test/interview, after due screening of applications, on the basis of qualifications, experience etc.
